ALL students must have health clearance, verification of influenza vaccination (with Lot # & Expiration date), a valid CPR certification and verification of a clinical background check by CastleBranch prior to the start of classes. The due date for these documents was July 15, 2019. **FAILURE TO HAVE THE ABOVE DOCUMENTS WILL RESULT IN A CLINICAL ABSENCE.**

\*\*\**In the mini courses (6 weeks), you are allowed **a one-half (1/2) day clinical absence.*** Malpractice insurance is provided by CUNY.

- ✚ CastleBranch Background Check (log on to your account and print report) – 3 copies***
- ✚ Proof of Flu Shot – 3 copies (August 2019)***
- ✚ CPR – 3 copies***
- ✚ A copy of influenza vaccination including lot number, date of expiration and name of vaccine manufacturer **must** be brought to the clinical agency on the **first clinical day**. Failure to do so will result in you not being permitted to remain in the clinical area as mandated by the clinical agencies.***
- ✚ Please retain a copy of each of these; some of the clinical agencies require a copy of this documentation for their records.***

**REMINDER: If you have not already done so, please check with the staff in the Nursing Department Office to see if you are required to attend an orientation prior to the beginning of class. If the agency to which you have been assigned requires this orientation, it is mandatory that you attend on the assigned day or you will be required to sit out for a semester.**
